He joins AmTrust after 15 years with Admiral Insurance, where he most recently served as National Vice President of Professional Liability Underwriting Strategy and Analytics. His prior roles at Admiral included Vice President of Professional Liability and underwriter, following an earlier underwriting position at CNA.
